Objects of the Society -

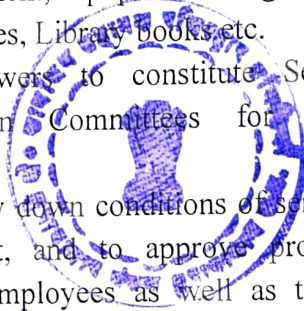
- The society is maintained and administrated by the members of Jain Community belonging to Uttar Pradesh.
- The society is especially meant for the benefit of Jain Minority Community and in general for all cast and creed of the society
- The society shall establish Institutions to impart Basic, Secondary, Graduate, Post Graduate, Teaching Education inclusive of education in Teaching Methodology & Physical Education, Technical Education of all segment i.e. Education in Business Management, Pharmacy, Nursing, Para Medical & other Professional Education by full filling the norms & standards laid down by the Central Govt./ State Govt. and concerned Council / Board mainly the followings -

- 1.The Society shall ensure that the school gets proper land, building equipments, furniture and qualified staff at least as per norms of the Board.
- 2.The Society shall ensure that the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
- 3.The Society shall ensure that the funds accruing from the school are spent for the benefit of the school and for its expansion.

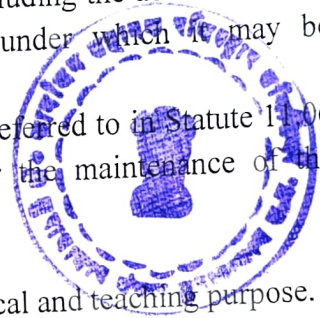

4. The Society shall safeguard the autonomy of the Principal and provide him total support except when the Principal goes against the established and clear directives laid down by the management.
5. The Society shall have control over the school management committee and shall approve the budget/tuition fees and annual charges etc., for the school.
6. The Society shall have control over any capital expenditure i.e., on land and the construction of building, its expansion and procurement of major equipments for the school.
7. The Society shall generate funds for the needs of the school whether it is recurring or none recurring.
8. The Society shall ensure that the school has the basic essential facilities such as Laboratory equipment, equipment for games and sports and other co-curricular activities, Library books etc.
9. The Society shall have the power to constitute Selection Committee/Departmental Promotion Committees for various categories of staff.
10. The Society shall have powers to lay down conditions of service as per norms of CBSE /Government, and to approve promotion /appointment /termination of the employees as well as to grant special increments or rewards to the staff.
11. The Principal of the College shall be 'ex officio' member of the Management Committee of the College.
12. Twenty -five per centum of the members of the Managing Committee of the College shall be teachers of the College (including the Principal).
13. The teachers (excluding the Principal) referred to in clause (b) are such members for a period of one year by rotation in order of seniority.
14. Subject to the provisions of clause (c) no two members of the Management Committee shall be related to each other within the meaning of the explanation to Section 20.

15. No change in the said constitution shall be made except with the prior permission of the Vice-Chancellor.
 16. One members of the Management Committee of the College shall be from the non-teaching class III employees of the college selected for a period of one year by rotation in order of seniority.
 17. If any question arises whether any person has been duly chosen as, or is entitled to e a member or office bearer of the Management Committee of the College or whether the Management Committee is legally constituted, the decision of the Vice-Chancellor shall be final.
 18. The college is prepared to place before any person or persons authorized by the Vice-Chancellor or before the panel of inspections appointed by the University all original documents pertaining to income and expenditure of the college including the accounts of the Society, Trust, Board or Parent body under which it may be operating.
 19. The income from the Endowment Funds referred to in Statute 14-06 of the University shall be available for the maintenance of the College.
- d. To Establish Charitable Hospital for Clinical and teaching purpose.
 - e. To establish Hostels with financial aid from Government of India or any other Government body/ NGOs.
 - f. To adopt any type of Govt. Sponsored programme for Social Welfare.
 - g. To do all other acts and to discharge all other duties which may be found necessary from time to time for development and administration of the Society.
 - h. Society shall work on "NOT FOR PROFIT "basis.

AMENDED CONSTITUTION OF MANAGEMENT
OF
PUSHPANJALI EDUCATIONAL SOCIETY
M.M.IG-136, Ramganga Vihar, Phase-I, Moradabad

This Constitution shall be called the
Constitution of Pushpanjali Educational Society

Area of Operation of the Society - Whole of Uttar Pradesh

1. Definitions:

(a) Act: Act means Society Registration Act 1860 and/or any other act for the time being in force, which may be applicable to the society.

(b) Chairman: 'Chairman' means, whether male or female who shall act as Chairman of the General Body / COM. The female may be called as 'Chairperson', in which event, the word 'Chairman' may, whether altered or not, will mean and include 'Chairperson'.

(c) Committee: 'Committee' means the Committee of Management (for short 'COM') reasonable for the Management of the affairs of the Society.

(d) Constitution: 'Constitution' means Constitution of Management of the Society.

(e) General Body: 'General Body' means the Body comprising of Life members, ordinary members and honorary members, other than the Committee of Management or any other committee constituted for any specific purpose.

(f) College: 'College' means any college to be Establish under the auspices or the Society.

(g) Membership Committee: 'Membership Committee' means the Committee referred to in Clause 6 of the Constitution.

(h) Property: 'Property' means all property, whether movable or immovable, which may be used for the establishment and administration of the Society and for activities run by the Society.

(i) **University:** 'University' means the University or the Body to which the College shall be affiliated for Graduate & Post Graduate Courses.

(j) **Board:** 'Board' means the Educational Board or the Body to which the School/Institution shall be affiliated for Primary / Secondary/Higher Secondary/ITI/Polytechnic Courses.

4. Composition of General body:

(1) The General body shall consist of the following members:-

(a) Life Members:

Every Member paying atleast a sum of Rs. 51000/- shall be member for life. The minimum sum may be enhanced by and at the discretion of the general Body.

(b) Ordinary Members:

Every person who has subscribed membership fee of Rs. 100/- for term of 'COM' and who has been enrolled as an ordinary member in accordance with this Constitution This sum may be enhanced by and at the discretion of the General Body.

(c) Honorary Members:

Any eminent educationist or technocrat or a prominent social worker may be taken as an honorary member for a maximum period of COM at one time. Such member may be required to pay honorarium Rs. 100/- to the Society.

The chairman and Secretary of 'COM' shall be the Chairman and Secretary of General Body, respectively. The Secretary, in consultation with the Chairman fix a date of meeting(s) of General Body and, as directed by the Chairman, shall convene the same.

5. Process of Enrolment & the Membership Committee:

(a) No person shall have a right to be enrolled as a member. A person other than the Life member referred to in Clause 5(a) and Honorary Member referred to in Clause 5(c), desirous of becoming a member of general Body, shall

submit an application recommended by atleast one life member to the Chairman alongwith a bank draft or pay order of the sum required to be paid in connection with the membership concerned. His/her application and the draft/pay order shall be put at a meeting of the Membership Committee comprising of Founder Office Bearers (Chairman /Secretary of General Body) and 1 Member of General Body, who shall have the absolute right to allow or reject the application. When allowed, the intimation thereof shall be given to the applicant. The absence of intimation would not imply that the application has been allowed.

(b) The decision of the Membership Committee shall be final and not be called in question before the 'COM' or General Body or in any Court.

~~(c) The Founder Chairman have right / privilege to nominate his nominee in Membership Committee, who will survive him.~~

6. Composition of Committee of Management (COM)

The COM shall comprise of the following members

(A) Office Bearers

- (i) Chairman
- (ii) Secretary
- (iii) Treasurer.

(B) At least four members from general body who are not office bearers.

(C) Ex-Officio members as per provisions of the Act and/or the statutes and/or regulations made there under related with the society.

7. Election & Term of the Committee of Management:

(a) Persons forming COM' shall be elected from amongst and by the members of the General Body.

(b) The term of the 'COM shall be at least five years.

8. Filling up of Vacancies:

The vacancy in the 'COM. occasioned by the death or resignation of any person or for any other reason shall be filled up by General Body by majority.

9. Powers and Functions of The General Body:

The General body shall be the supreme body of the Society. It shall be an appellate authority against the decision(s) of the COM', It shall have the power to vary or set aside the decision taken by the COM'. The power shall be exercised by the General body at a Meeting held for the purpose of appeal and taken by majority of votes. The general body at its discretion may stay the decision of the 'COM'

The decision of the General Body shall be final.

10. Casting Vote:

In the event of equality in votes cast at any meeting the Chairman shall have the right in addition to casting his/her vote as a member, to cast one more vote as a 'Casting Vote'.

11. Quorum:

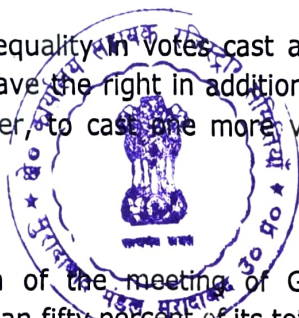
(a) The quorum of the meeting of General Body shall comprise more than fifty percent of its total members.

(b) The quorum of the COM' shall comprise of above 50% members of the COM in addition to one of the ex-officio member referred to in Clause 7(C) of the Constitution

12. Postponement and Adjournment of Meetings:

The Chairman shall have the right to postpone and adjourn the meeting for any cogent reason.

The meeting adjourned for want of quorum shall have quorum comprising of Members present at the meeting.

13. Notice and Agenda of the Meetings:

(A) (i) The notice signed by (he Chairman or the person directed by him, referring (he agenda of the meeting of the General Body, shall be in writing at least ten days before the date of the meeting scheduled to be held. In case of a special meeting, three days notice shall be sufficient.

(II) The General Body shall meet at least once a year.

(B) (i) The notice signed by the Chairman of COM or the person directed by Chairman, referring the agenda shall be issued in writing at least three days before The date of the meeting scheduled to be held.

(ii) The COM shall remain authorized to meet as many times as it may deem lit, but ordinarily, it shall meet at least once in a quarter of the year.

The period of five years shall commence from the date when the COM comes into being.

14. Functions of the Committee of Management:

The rights and duties of the 'COM' shall be as follows

(a) To manage the College, Hostels, Hospitals & Any other activity under the auspices of the Society having full control over the property of the Institutions.

(b) To draw and approve the budget:

(c) To appoint, confirm, suspend and dispense with the services of and

- (f) To receive the grants given by the Govt. or other Bodies and to spend them:
- (g) To authorize any of its members to initiate or defend the legal proceedings and the person so authorised shall be entitled to appoint or dismiss any lawyer for this purpose,

15. Powers and Duties of the Office Bearers of the 'COM'

(A) Chairman:

(i) He/she shall preside over all kinds of meetings. However, he/she shall have the authority to nominate any other person from amongst the Office bearers or members of The 'COM' to exercise this power.

(ii) For the purpose of holding meetings he/she shall fix the dates and draw the agenda.

(iii) He/she shall have the power to change the dates of the meetings.

(iv) He/she shall have the power to represent the COM' before any Authority.

(v) He/she, along with Secretary or Treasurer, shall operate accounts. He shall disburse salary of the staff as well as make payments to any person in connection with the affairs of the activities of the Society.

(vi) He/she shall have the authority to enter into correspondence with anyone,

(vii) He/she, on behalf of 'COM' shall ensure that the terms and conditions of the affiliation of the College are fulfilled.

(viii) He/she shall exercise all the powers of the 'COM' in any emergent case and he may get it ratified by the COM.

(C) Treasurer:

- (i) He shall assist the Secretary in keeping and maintaining accounts. In addition to it, as one of the operators of accounts, he shall sign, as aforesaid, cheques and other instruments which may be used for withdrawal of sum(s) for the Society.
- (ii) In the absence of Secretary the treasurer shall exercise such or any of the powers of the Secretary.

16. Bank(s)/Books /Records /Audit:

(a) The funds of the Institute shall be deposited in any of the Nationalized, Chartered or Co-operative Banks as per decision of the 'COM'.

(b) The account(s) shall be jointly operated by the Chairman and Secretary or Jointly by the Chairman and the Treasurer.

(c) The records and the accounts shall be maintained and get audited by a Chartered Accountant as per Law.

(d) The Society /Committee of Management / College may borrow loan /receive advance /over draft of money from the Banks / Financial institutions /Private financial organization as and when required by mean means of pledging /mortgage as security the immovable property of the society/College subject to the condition that the Chairman of the COM shall the documents with Secretary or Chairman with Treasurer, for arid on behalf of committee of Management etc.

17. Petty Cash:

In order to meet minor expenses, the 'COM' may place, at the disposal the Chairman, such sum as it may deem lit.

18. Cessation of Membership:

A person holding membership of general body of 'COM' or Membership Committee shall cease to be a member if

- (a) He has resigned from the General Body or the COM or Membership Committee. or
- (b) He has not paid the required sum, which in the opinion of the 'COM, is due towards him; or
- (c) He has been adjudged un discharged insolvent, or he has been directed to execute a bond LI/S 109 or 110 Cr. P. C.; or
- (d) He incurs any disqualification U/S 16 — A of Societies Registration Act. or
- (e) He, in the opinion of the 'COM', has acted to the detriment of (he interest of the College, or
- (f) Any Court of competent jurisdiction or authority has held that he is a person not desirable to hold the membership: or
- (g) He has become a man of unsound mind — the unsoundness being incurable.

19. Settlement of Disputes:

- (i) The internal dispute, if any, inclusive of interpretation of these presents, shall be settled by the 'COM' and its decision subject to appeal to General Body, shall be final,
- (ii) The 'COM' may sue and defend, in its name and at its expenses, all legal proceedings.

20. Change in the constitution:

Only the General Body referred to herein above by 3/5th majority shall have the authority to make alterations and other amendments in the Constitution. Inclusive of those relating to the powers and duties of any aforesaid office bearer(s), but no amendment shall be made curtailing the powers of the Chairman unless he gives his consent in writing to this effect.

21. Procedure for Dissolution and Disposal of the property:

(a) (i) If the objects of the Society cannot be achieved or these are frustrated, the Society may be dissolved at a decision taken at a meeting of The General Body.

The meeting shall be called on the recommendation of the COM' and Provisions of Sections 13 & 14 of the Societies Registration Act shall apply.

(ii) The decision shall be taken by not less than two upon three members present at the meeting 0

(b) On dissolution, the property of the Society / College established by the Society shall be disposed of in the following manner: -

" If the Society is to be dissolved or wound up for the reason that the objects of the Society cannot be achieved or for any reason deemed fit by the society, then the assets remaining as on the date of dissolution or winding up, shall be transfer to another Society having the similar objects of charitable nature".

22. ~~CODE~~

(i) That the society shall be renewed time to time under who's auspices school is running.

(ii) That there will be one member selected by Education Director/ Associate Education Director in School Managing Committee.

(iii) That there shall be atleast 10% students from SC/ST Category and shall be charged fees as per UP Primary School or as per schools operated by Basic Shiksha Paishad only.

(iv) That School shall not ask for any grant from State Govt. Also, if the School is recognized by Secondary Board of Education and affiliated to CBSE, New Delhi/ Counseling for

the Indian School Certificate Examination, New Delhi in the past, then in that case from the date of recognition received in the past, the recognition and grant from shall auto cancel.

(v) That the teachers and other staff of the school shall be paid salary and allowances as per schools granted by State Govt.

(vi) That there shall be a Staff Service Rules and Regulations as per the schools granted by State Govt. and shall be facilitated the same.

(vii) That school shall follow all rules and regulations instructed by state Govt. time to time.

(viii) That the School Record shall be kept in prescribed format.

(ix) That all above eight points shall not be changes until any new change in rules passed.
